Contributions are not tax deductible. Federal law requires us to use our best efforts to obtain and report the name, address, employer and occupation for each individual whose contribution aggregate in excess of \$200 per election. Individuals may contribute a maximum of \$5,800 (\$2,900 for the primary election and \$2,900 for the general election) and couples may contribute a maximum of \$11,600 as a joint contribution for the 2021-2022 election cycle. Contributions from corporations, foreign nationals without lawful permanent residence status, and federal government contractors are prohibited.
